2.1	Window Cleaning	

Reference was made to previous minute item 1.1, with it being advised that Box Cleaning do not have the equipment to reach the higher floors of Lymington Road's (site-facing) windows. New equipment has been advised as being procured, with it to be established by the LRs as to whether this has been progressed.

#### 2.2 Lean-to Demolition Works

Reference was made to previous minute item 1.2, in relation to the remaining demolition works to the lean-to structure and piling in association. # 2.4 Noisy Works

Reference was made to previous minute item 1.4, in respect of noisy works. It was noted that the noise emitted from the brick cutting machine was a major issue in the period, with JSa suffering perforated eardrums as a result. The machine has now been moved away from the Lymington Road boundary, with it advised that the previous location was required for forklift access.

#### 2.5 Tree Protection
